## **Property Redevelopment Discernment Committee**

The following is intended to provide the Congregation with an understanding of the progression of the work being carried out by the Property Redevelopment Discernment Committee.

#### **Background**

As many of us know, the City of Ottawa has undertaken a review of the lands surrounding the future Pinecrest and Queensview O-Train stations to guide future development that supports transit and improves connectivity with the surrounding neighbourhoods. It is also conducting a study on the Lincoln Fields Station area which aims to facilitate a more urbanized place that helps meet the City's intensification targets and strategically locate density in proximity to the future Lincoln Fields O-Train Station. In addition to these important development plans around Britannia United Church, the City has seen a significant increase in the demand for housing.

It was in this context that Kathy Vandergrift, Chair of the Queensway Terrace North Community Association made a presentation on April 16, 2023, to the Congregation of Britannia United Church. Queensway Terrace North is the neighbourhood bounded to the north by Carling Avenue, to the west by Pinecrest Road, to the south by the Queensway (Highway 417), and to the east by the Transitway.

Britannia United Church has been operating at a deficit for many years. Between 2010 and 2023, annual operating losses steadily increased, while yearly offerings declined. While the Church has navigated through these growing deficits over the last few years, it is becoming more challenging. Further, the demand on aging volunteers is ongoing and membership is declining. These issues are not unique to our Church.

Hence, the Church Council mandated a committee, composed of Kelvin Stanke, Chair of Council, Colleen Chambers, Treasurer, and Helen Hutcheson, Chair of Stewards, with Rev Jen Power as the ministry resource, to gather information, and explore redevelopment options to support the sustainable, ongoing ministry of the Church. This Committee has taken on the responsibility of presenting various options on what the future of our Church could look like and providing information to the Congregation to review and discern the options.

#### **Actions Taken**

The Property Redevelopment Discernment Committee has taken a number of steps to begin gathering information on possible options:

- Contacted the City Counsellor, Theresa Kavanagh, and her staff, as well as a Senior Planner with the City of Ottawa.
- Met with Kindred Works, the development arm of the United Church of Canada, created in 2019 to repurpose its properties as a response to Canada's housing crisis.
- Requested that Kindred Works prepare a feasibility study. This was a high-level look at what was possible on the Britannia United Church property, with initial options for housing with a new church worship space. All discussions were exploratory.
- Reviewed the feasibility study with the Church Council which decided that the options and next steps should be presented to the Congregation for information and discussion.

The Committee was given a mandate to hold a Congregational meeting and ultimately provide the Congregation with the opportunity to vote on an option for the future of the Church.

• Held Congregational meetings on December 3 and 10, 2023. Many comments, questions and concerns were noted.

#### **Activities Underway**

As its name implies, the Committee will continue its process of discernment. We are working together with the Congregation to determine whether the property should be redeveloped and what the possibilities for this redevelopment are. To assist with further research and the process of discernment, Leigh Bain joined the team in December 2023. Diane Houston has also been assisting the team with research.

Rev Jen is leading listening circles to take the temperature of the Congregation, listen to concerns and note questions.

The Committee is continuing to pursue its research by:

- Determining the fair market value of the Church's property based on current and proposed changes in zoning;
- Consulting with other churches, including other United Churches in the area, to discuss strategic options and sustainability;
- Consulting with other churches which have experience working with Kindred Works;
- Reviewing the proposed Letter of Agreement with Kindred Works;
- Monitoring developments with the City; and
- Narrowing, and clarifying redevelopment options.

Once all this research has been compiled, the Committee will share a document and engage in further discussion with the Congregation. Any decision concerning future redevelopment must be made by the Congregation.

### A Possible Partnership with Kindred Works

Should the Congregation choose to partner with Kindred Works, the Property Redevelopment Discernment Committee and members of the Congregation would move to the next stage with them, which would permit Kindred Works to further analyze and develop a design that meets the needs of the Congregation. Kindred Works requires that the Congregation demonstrate their interest for further analysis by signing a Letter of Agreement. There is no monetary cost to Britannia United Church to moving to the next stage and it does not commit us to continuing to work with Kindred Works to redevelop the property.

The next stage involves Kindred Works, who would invest up to \$50,000, at their cost, in architectural, engineering, and other professional fees to facilitate work on a document to provide full details of what a potential redevelopment could look like. This document would provide details such as the revenue stream from the rental units to the Church, parking and property management details and much more to provide the Congregation with the information we are all seeking. It is expected and identified in the Letter of Agreement, that Britannia United Church would have full use of and autonomy in the space in a new development.

After reviewing the document provided by Kindred Works, the Congregation would have the opportunity to vote a second time to move forward, or not to move forward, with the detailed redevelopment plan proposed by Kindred Works. If the Congregation decides NOT to move forward with the Kindred Works plan, the Church would be required to repay \$50,000 ONLY IF and WHEN the Church sells the property. The amount of \$50,000 would likely be a small percentage ( $\sim$ 1%) compared to the proceeds of the sale of the property.

#### **Discernment Decision**

The Congregation needs to determine what the future of Britannia United Church looks like. We have an option to be part of a solution to the housing crisis, while at the same time, providing a sustainable revenue stream. We also have the option to sell the property and use the proceeds of the sale to relocate and contribute financially to the community in other ways. Another option is to amalgamate with a neighbouring United Church. These options would provide funds to operate the Church and allow a focus on ministry to the community versus just managing expenses. As a community of faith, the Congregation needs to determine the way forward for our Church and our collective wish to best meet the needs of the community.

The Property Redevelopment Discernment Committee trusts that God is guiding us each step of the way as we lead this process of discernment with our Congregation and how we can best follow in the way of Jesus.
